IDENTITY VERIFICATION FORM

The Department of Education has chosen you to complete Identity Verification. This can be done by presenting an unexpired, valid, government-issued photo identification such as a U.S. passport, a driver’s license, or other state-issued ID to the UNI Office of Financial Aid & Scholarships. This may be done in one of the following ways:

1. Appear in person and present the acceptable identification to an authorized individual in the UNI Office of Financial Aid and Scholarships.
2. Verify your identity with a service provider that is compliant with the National Institute of Standards & Technology Identity Assurance Level 2 (NIST IAL2). Provide acceptable documentation directly from the service provider confirming the date of the verification and that your identity was verified under the NIST IAL2 Standard.
3. If you are unable to appear in-person with the UNI Office of Financial Aid & Scholarships to verify your identity, you may complete the form below in the presence of a Notary. The Notary must complete the second page of the document stating they reviewed your valid government-issued photo identification. The last part of the document is a Certification and Signature section you must sign.

**Identity Verification**

If the student is unable to appear in person at the UNI Office of Financial Aid & Scholarships to verify his or her identity, the student must provide to the institution:

- a. **A copy of the unexpired valid government-issued photo identification (ID) that is acknowledged in the notary statement below or that is presented to a notary, such as, but not limited to, a driver’s license, other state-issued ID, or passport.**
