IDENTITY AND EDUCATIONAL PURPOSE

(To Be Signed at the Institution)

The student must appear in person at the University of Northern Iowa - Office of Student Financial Aid & Scholarships to verify his or her identity by presenting an unexpired valid government-issued photo identification (ID), such as, but not limited to, a driver's license, other state-issued ID, or passport. - b. The original Statement of Educational Purpose provided below, which must be notarized. If the notary statement appears on a separate page than the Statement of Educational Purpose, there must be a clear indication that the Statement of Educational Purpose was the document notarized.
