

Des Moines Area Community College Business Teaching

For students planning to transfer to UNI for a major in Business Teaching, the following plan of study is generally recommended:

1. Complete an Associate of Arts (A.A.) at Des Moines Area Community College

ADMISSION TO COLLEGE OF BUSINESS REQUIREMENTS

1. 30 cumulative semester hours of college credit
2. C- or better in ECON 1041 - Principles of Macroeconomics
3. C- or better in the following:
 - a. ECON 2090 – Decision Analytics (pre-req STAT 1772 or equivalent) OR
 - b. ECON 1011 – Stats for Business Analytics (pre-req of STAT 1772 or equivalent)
4. C- or better in an approved English composition course, such as ENGLISH 1005 - College Writing and Research (this would be the equivalent of Composition I & II at a community college)
5. Total or UNI cumulative GPA of at least 2.50 on all university-level courses

6. Declaration form filed with the UNI Business Advising Office
(which you will do at Transfer Orientation)

CHECKLIST FOR ADMISSION TO THE UNI TEACHER EDUCATION PROGRAM

- Have a declared major
- Have a cumulative GPA of 2.5 (or higher)
- Earned credit for TEACHING 2017 or equivalent
- Have completed an acceptable Application to the Teacher Education Program
